Expert Advice: Product & Partner Selection

Fund Manager Selection

Funds are shortlisted based on the following parameters:

- Domicile- Preference is for well reputed jurisdictions
- Fund manager vintage and licensing
- Third party service providers such as auditor, fund administrator, custodian, broker vintage
- Asset class coverage within the Kristal fund universe- Preference is to have a wide range of asset classes rather than wide range of funds within an asset class
- Firm investor demand



Investment Committee Due Diligence

The Investment Committee finalises shortlisted funds based on the following parameters:

- Fund Performance- Funds are ranked and then assessed based on their:
 - IRR
 - Sharpe ratio and sortino ratio
 - Volatility
 - Maximum drawdown
 - Number of negative months etc.



Broking Platform Selection

**Partners are selected post rigorous due diligence,
some of which are:**

- Number of years in business
- Management team vintage
- Transaction volumes handled
- Licensing authority and domicile of partner
- Technology capabilities and whether or not API driven
